
# **Details & Governance**

The framework was procured in compliance with the Public Contract Regulations 2015 Restricted process and has a 4-year term. Customers can use any form of contract under the JCT and NEC suites of contract, or any other bespoke form of contract.

The following areas were assessed as part of the procurement process and are continually monitored throughout the duration of the framework:

- AS91 compliance
- Maintenance of appropriate insurance levels
- Health & Safety Accreditation e.g. SSIP
- Financial robustness
- Performance and adherence to KPI's

# How To Award Work

To make an award under the framework, the Access Agreement needs to be completed and approved for each project (add lnk)

### The Framework provides 2 methods for awarding a contract

- Direct Award
- Further Competition
- **Direct Award**

To place a direct award contract following approval of your Access Agreement, you will need to undertake the following:

 Identify the Lot which the requirements fall within

- Identify the Framework Provider which best meets your requirements taking into consideration:
  - Location
  - Time
  - Cost
  - Repetition of existing/similar work
  - Form of Contract
- Contact your chosen Framework Provider and place an order following acceptance of the quoted requirements in relation to time, cost and quality

#### **Further Competition**

To ensure a compliant further competition process your competition will need to comply with the following requirements, following approval of your Access Agreement:

- Identify the Lot which the requirements fall within
- Supplement and refine the Call Off Terms & Conditions e.g. JCT, NEC etc.
- Invite tenders by conducting a further competition for the requirements in accordance with regulations and evaluation methodology
- Apply the award criteria to all compliant tenders
- Place an award with the successful Framework Provider

## The Evaluation Methodology for a further competition can be set by the Customer but must comply with the provisions of the following table:
